## Restorative Solutions are recruiting for sessional facilitators to deliver CARA (Cautioning and Relationship Abuse) workshops across West Yorkshire

If you are looking for a new challenge and want to be part of delivering an innovative response to tackling domestic abuse, then this could be the role for you. This is an exciting opportunity to join Restorative Solutions and take a key role in setting up and delivering CARA across West Yorkshire.

CARA targets standard risk domestic abuse offenders by offering two domestic abuse awareness raising workshops as part of a conditional caution issued by West Yorkshire Police. We are working in partnership with the Hampton Trust to deliver CARA workshops across the area.

We are looking for skilled practitioners who have experience in delivering group work, knowledge of domestic abuse issues and an aptitude and ability to engage individuals from a range of backgrounds. Full training will be given, providing opportunities to develop and hone skills in motivational interviewing and to see the powerful impact of group work.

Workshops are delivered on a Saturday, for separate groups of male offenders of intimate partner domestic abuse, female offenders of domestic abuse, and offenders of non intimate partner inter familial abuse. You will be required to be available on site from 9am-4pm on the days you are booked to deliver CARA. Delivery sites are across West Yorkshire. There is no requirement to be available each week; rather we are looking to recruit a pool of facilitators who will be scheduled to deliver CARA Cohorts (pairs of workshops) subject to their availability and proximity to the delivery sites.
